The said fund is accumulated after transfer of money from Admin Account to SPF Staff Pension Gratuity Fund Account by making provision in every financial year within the income, with approval of the government.

As per actuarial valuation report as on 31.03.2018, the total liabilities in Staff Pension Gratuity Fund Account is Rs. 16.00 crores and total accumulation including investment of Staff Pension Gratuity Fund Account is Rs. 7.72 crores as on 31.03.2018.

However, the shortage of Rs. 8.28 crores in funds of SPFO's Staff Pension Gratuity Fund Account may be recouped every year after making provision within the budget. In the F.Y. 2018-19 Rs. 1.32 crore has been transferred to Staff Pension Gratuity Fund Account.
