Corrigendum

The Following Clarification are hereby made for RFP for the appointment of Portfolio Manager.

2. As there are only three covers allowed for uploading the bids in a defined format (as mentioned in the below table), the bidders shall upload / submit the bid data in the following manner.

Cover No.	Cover	Document Type	Details of the bid document to be uploaded/submitted by the bidder
1	Fee	.PDF	Proof of deposit of non- refundable bid processing fee charges of Rs. 2500/- (Two thousand five hundred only) in favour of "Seamen's Provident Fund Admin Ac." As per para 6.1.7 of RFP
2	PreQual/Technical	.PDF	Bidder shall submit the bids required under prequalification and Technical criteria a single document clearly segregating the bid as 'Pre-qualification Bid' and 'Technical Bid'. Also, the cover letter of the financial bid shall be uploaded along with technical bid clearly segregating it as 'Cover letter for financial bid'.
3	Finance	.XLS	Bidder shall submit the financial bid in the format of the table as provided in the para 8.4.1 of the RFP.

Kindly note that

1. As per the para 6.3.2 of the RFP, All Bidders, who qualify on the pre-qualification bid criteria, would be eligible for evaluation of their technical bids.
2. Only cover letter of financial bid shall be submitted under cover no. 2. If Financial bid is uploaded under cover no. 2, then the bid submitted by the bidder shall be rejected.
3. Bidder is required to submit the excel file named 'Technical Bid Data' containing the technical bid data in the excel format as required under para 8.3 of the RFP. Bidder shall submit this excel file in pen-drive (the excel file must be password protected) to the Commissioner, SPFO at the time of the opening of the pre-qualification bid. If bidder fails to do so, the bids submitted by the bidder shall be considered incomplete and will not be evaluated. The bidders, who qualify on the pre-qualification bid criteria for evaluation of their technical bids, will be asked to share the password of the excel file titles 'Technical Bid' submitted in a pen-drive, at the time of opening of technical bid. The technical bid submitted in the PDF format shall be considered for the evaluation of the bid.
